

The Paiyun Rural Municipality invites sealed quotations from registered Suppliers or manufacturing companies for the supply and delivery of Gabion Box & HDPE Pipe.

1. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Paiyun Rural Municipality, Huwas Parbat. Tel.067411101
2. A complete set of Bidding Documents may be purchased from the office of Paiyun Rural Municipality, Huwas Parbat. by eligible Bidders on the submission of a written application, along with the copy of company / firm registration certificate, and upon payment of a non-refundable fee of NRs. 1000.00 till 2075/12/05(19th March 2019) during office hours.
3. Sealed bids must be submitted to the office Paiyun Rural Municipality, Huwas Parbat.12:00 pm on 2075/12/06(20th March 2019) Bids received after this deadline will be rejected.
4. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2075/12/06(20th March 2019) 2:00 pm the office of Paiyun Rural Municipality, Huwas Parbat. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of following amount which shall be valid for 30 days beyond the validity period of the bid . If bidder wishes to submit the Cash Security, the cash should be deposited in Account No. 0660300000003000010 (Ga-3-1 DHARAUTI) at Nepal Bank Ltd. Kusma Parbat. and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
5. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
6. The Purchaser reserves the right to accept or reject, wholly or partly any or all the Sealed Quotations without assigning any reason, whatsoever.
7. Any conditions so far not covered shall be as per Public Procurement Act-2063, Public Procurement Regulations-2064.
